

## INTERROGATION BY DON RONEY NO DATE OR TIME GIVEN

- Q. Would you kindly hold that please, Mike. Mike, hold the mike. Mike would you kindly state your name.
- A. Mike Wehrung.
- A. How do you spell your last name. Mike?
- A. WEHRUNG
- Q. Where do you live, Mike?
- A. 6 Illona Drive.
- Q. Mike, how old are you?
- A. 15.

Here is some conversation with another party about whether the mike is on and Roney says it is on.

- Q. Mike, you're acquainted with this Patty -
- A. Rebholz?
- Q. Yes, Rebholz.
- A. Yes.
- Q. How long have you know Pat?
- A. Just known her, you mean?
- Q. Yes, like the date from then.
- A. Well, I guess I've known her, but not very well, for about three years, I guess.
- Q. In other words, she's lived here in the City of Greenhills that long?
- A. I don't know about the same house, but I think she started in about the 6th grade here, I mean as much as I know.
- Q. Then you've known her since you attended school here?
- A. Yes. Well high school, when we started going together.

- Q. How long has it been since you've been close friends?
- A. About 5 months I guess.
- Q. You dated her exclusively. Is that right?
- A. Yes.
- Q. Where did you go generally on dates? What did she like?
- A. Mostly we went to a miniature golf course; to play putt-puttor the driving range, or once we went to a drive-in.
- Q Now, getting down to August 8, Mike, did you see her any time during that day that was yesterday?
- A. No, no.
- Q. You didn't see her any time, but she called?
- A. Yes, but I didn't answer. During the afternoon I called her.
- Q What time was that?
- A During the afternoon I called her but she wasn't home, and I got hold of her about a quarter of six.
- Q. What was the nature of that conversation?
- A. Just to call her, I call her every day.
- Q. Did she tell you what she was going to do that evening?
- A. Well, I knew she was going to a dance. She goes every Thursday
- Q. To the dance up here at the Legion Hall?
- A. Yes, at the Legion.
- Q. Did she tell you what time she was going?
- A. No. I don't know what time it starts, but at the same time she usually goes, but she usually goes over to Beth's first and they walk up from there.
- Q. Now then, did you see her before she went to the dance?
- A. No.
- Q. Did you hear from her while she was at the dance?
- A. I didn't talk to her but she called.

- Q. She called your house?
- A. Yes sir.
- Q. Where were you when she called?
- A. Downstairs. I was playing ping pong.
- Q. Who were you playing with, Mike?
- A. The bunch of guys, or just one guy?
- Q. Who were you playing with and who were the bunch of guys?
- A. Ray St. Clair, Bruce, Tom Bade, Butch Bowling, Dale Boyd, my sister, Cheryl, and Steve Tillett.
- Q. Which one were you playing with actually when she called?
- A. With Butch, I think.
- Q. What was the conversation?
- A. Well, she asked Cheryl, who asked me, if I could get up to the phone. I told her I had three more points to go as we were tied so she just yelled down "Is it all right if Pat comes over?" and I said sure. So I guess Cheryl told Pat she could some over.
- Q. About what time was this, then?
- A. Uh I guess it was about 9:30.
- Q. Then what happened? It took more time to finish the game?
- A. I had my swimming trunks on. I didn't get cleaned up or anything, I just put on some pants and a shirt. Then I waited on the porch.
- Q. What kind of pants and shirt did you have on?
- A. Levis.
- Q. Levis. And what kind of shirt?
- A. A striped shirt with a zipper. Then me and my Mom and my little sister waited on the porch, and she didn't come, so I thought that
- Q. You had all these people in the house, what did they do?
- A. They went to Henry's to eat.

- Q. Were they going to bring something back?
- A. My Mom asked for three. She though Pat was coming one for each of us.
- Q. What time did they leave?
- A. I guess it was about ten.
- Q. Did they go immediately after the game was finished? When the game broke up did they start to go to Henry's?
- A. Well, yeah, everybody got ready - - -
- Q. Now, then what did you do when they took off for Henry"s?
- A. I sat on the porch with my Mom and my little sister, and we waited and she didn't come, so I thought her brother might have picked her up she might have stayed with Beth and her brother picked her up and took her home, and I didn't want to call because I, you know, oh, I don't know why I didn't call, and I went in and watched the rest of the show with my Mom, and then Ray and them got back with the hamburgers and we ate, and everybody else went home, and Ray, Cheryl and I went downstairs and played cards.
- Q. What time was this?
- We watched the news, so it was after I know when Mrs. Rebholz called it was twenty till - I remember that. And she asked me if I had seen her, if she was over here, and I told her the story that she was supposed to come over. She started crying and said "O. K. thanks a lot". So then I called, I waited about half an hour, and called her back and she didn't hear anything, Mel was out looking for her, and then I hung up. My Mom got up. Whe went to bed while we were playing cards; she got up and then about two minutes later Mr. Rebholz came over. He asked to hear the story. I told him and he left. Then Mel came over, I mean Mel, Jr., and then he asked me if I wanted to go around with him, you know, to help look, so I said yes and Ray was coming down he went up to ask his mother if he could stay down here and wait with us longer. So we both went; we pulled up here on Ingram and parked the car and come up through the back and ran into Jack Leach and Mr. Rebholz, and then Jack told us to go, you know walk down through the cut-throughs, to see if we could see anything, and Mr. Rebholz said he would meet us there in about ten minutes. We went down and we didn't hear anything and Mr. Rebholz didn't mither.

- What do you mean by the cut-throughs?
- A There's sections of cut-throughs that go through the streets.
- Q. Did this go anywhere near the vicinity where the body was found?
- A. Not the cut-throughs didnt. Then Ray went home. Then my Mom went to bed and me and Cheryl stayed up and sat on the porch for awhile, and we went in and played some more cards on the couch. I guess it was about twenty minutes after three; we just decided to lay on the couch. We fell asleep and the next thing I knew my Dad was leaving for work and I got up and aaw the Greenhills Police car and I saw a Forest Park police car and the Forest Ranger car, and I saw an ambulance come up. Then I saw them take the stretcher out and I didn't see them put the body on it, but I saw them after they had the body in the blanket, or I saw them lift it up and put it in the ambulance. I didn't have any idea it was her, so then I just
- Q. Well what did you think it was then?
- A. I didn't have any idea then; I thought it was one of those Udry twins, I really didn't have any idea what was going on, but I didn't think it was her. And then, let's see, oh then I went back to sleep for about fifteen minutes, and Mrs. Upton called and said that they had found you know, Pat and next to the Udry house, and uh
- Q. You didn't go over there when the ambulance was there?
- A. No, not right away. And then after my Mom got done talking she asked me to get up and see what it was all about I got to the driveway and Jack and I guess two newspaper men, they started asking questions.
- Q. What did they ask you, Mike?
- A. They asked me to tell the story I just told to you, and did I have any idea why she would come over, and I can't think of them all.
- Q. Now, Mike, from the time she called about 9:30 P. M., did you leave the house between 9:30 and 10:00?
- A. Oh yes, I forgot to tell you. I was sitting on the porth you know, and after she called at 9:30, I thought sure she'd be here about twenty till, so I waited about ten more minutes, it could have been five, till I decided to walk
- Q. Five till what?

- A. Ten. So then I decided to you know to walk over down Jennings and see if I could see anything of her coming, so I cut across Udry's grass you know where she was found, but more sort of diagonal so I walked over there and looked both ways and I didn't see anything and I whistled, and you know, didn't hear anything so I figured her brother picked her up so I went back home.
- Q. Now let's get this straight. You were down in your cellar and the game broke up after her 9:30 call?
- A. Yeah.
- Q. And did you go upstairs then to wait for her?
- A. Yes. I got dressed and then I sat on the porch with my little sister and my mother.
- Q. Was this after the people went out for the hamburgers?
- A. Yes.
- Q. What time would you say you first went out on the porch?
- A. Oh, I guess a quarter till ten.
- Q. A quarter till ten. Was that when you first went out on the porch as close as you can remember?
- A. Yes.
- Q. Then you sat on the porch till?
- A. Oh, about five till, I guess.
- Q. How do you trace the time, Mike?
- A. About a quarter till ten.
- Q. I mean, how do you decide what time it was?
- A. Oh, I mean I approximated the time. I didn't look at the clock.
- Q. You approximated the time? Give or take five minutes?
- A. Yes.
- Q. Your little sister stayed on the porch with you, did she?
- A. No, she went in the house to watch she thought Thriller was on I mean Twilight Zone. She went in the house and I was out there a couple of minutes by myself and I decided to walk over.

- Q. Now when you walked over there, that boy said he walked by there. Did you see that boy?
- A. No. Cheryl said they saw him when they came back from Henry's; they saw Smith, you know, the one who said he saw the boy or something, so I was about ten minutes late for that, I mean, if I had waited for about ten minutes -
- Q. You mean Cheryl said they saw Smith when they were coming back from Henry's?
- A. Yes.
- Q. What time did they get back from Henry's?
- A. I guess it was about, about ten thirty, I guess. I mean I'm not sure.
- Q. They said they saw, that is Cheryl said she saw Smith when they were coming back from Henry's?
- A. Yes. Steve saw him too.
- Q. Steve?
- A. Steve Tillett.
- Q. Steve Tillett saw Smith?
- A Yes, Steve saw him coming back from the doctor's office, I guess.
- Q. They were coming back from getting hamburgers?
- A. Yes, they were coming home.
- Q. They were coming from there and they saw this Craig Smith?
- A. Yes.
- Q. They aaw him in that vicinity? And that should have been about 10:30?
- A. Around that, I guess, yeah.
- Q. It would take anywhere around 45 minutes to go and get hamburgers, wouldn't it?
- A. Not just to ride over there. You mean altogether?

- A. Yes.
- Q. Yeah, about that I guess. They might have had to wait.
- Q. Where did they go to get hamburgers?
- A. Up at Galbraith and Winton.
- Q. At Galbraith & Winton?
- A. It's right on Galbraith, next to the gas station, Henry's Hamburgers.
- Q. Forty-five minutes should do this- somewhere around in there?
- A. Around there, yeah.
- Q. When they came back, at that time did they say anything about seeing Smith?
- A. No, not to me they didn't. I don't know if they said anything to anybody else, but I don't remember anybody telling me.
- Q. You have a Rambler automobile, a white one?
- A. Yes.
- Q. Did you take that out at any time and drive
- A. On Wednesday?
- Q. No, no, around ten o'clock that evening and drive it?
- A. Oh, no.
- Q. Now earlier in the evening did you go over to see St. Clair?
- A. Yes, at the horse.
- Q. Now tell us what happened.
- A. Well, Cheryl and I go to the horse Ray has a horse down on Winton Road. You know we have a keg fixed up in the basement you know my Dad didn't want to mess with the bottles, and he wanted us to go down there and get it, and so he told me to go down to the horse and pick her up so she could drive in and get the beer and then come home.
- Q. Where did you drive to?
- A. Up to the horse.

- Q. Q. Where did you get the beer?
- A. At my grandfather's.
- Q. Your grandfather's at his place in Corryville?
- A. Yes.
- Q. Oh, then you went over to the horse. What time did you get over at the horse?
- A. Just a little before dark. I don't really know, just dusk about.
- Q. Then you drove over there and picked up Cheryl. Did she drive from then on ?
- A. Yes.
- Q. When you got over to the horse did you do anything?
- A. I got out of the car and got in on the other side.
- Q. You got out of the car and walked around and got in on the other side?
- A Yes, I walked around the front.
- Q. You didn't ride the horse or anything?
- A. No, we left right away.
- Q. When you got back was St. Clair back from the horse?
- A. Yeah, I think he was. I had to get that keg out of the back and take it in. I think Cheryl went up to Ray's, I'm not real sure.
- Q. And then eventually he came down?
- A. Yes.
- Q. Have you any idea what time he arrived at your house?
- A. No, it's a half hour there and a half hour back.
- Q. O. K. Now going back about three weeks, did you and Pat have a little tiff, so to speak?
- A. An argument you mean?
- Q. Yes.
- A. Nothing real serious; I mean everybody has these little I can't even remember what it was about.

- Q. Was it about somebody she went to the dance with?
- A. When was this, about three weeks ago? Yeah, I think it was. She didn't go with him she just met him there. She had to stay with this girl, Beth, you know, and Beth wanted to go with these she knew them, you know, they weren't strangers, and they wanted to go to Frisch's, and this is the way I heard it, and Pat said "No" and Pat had to stay with Beth and Beth said "Well, I'm going", so they got in the car and this guy tried to kiss her, and that's what we got in the argument about.
- Q. How do you know he tried to kiss her?
- A. She told me.
- Q. Pat did?
- A. Yeah.
- Q. She called you and told you all this? You didn't have to find it out for yourself?
- A. No. She called when I was gone to summer school and when I got home Mom said to hurry up and call back that she had something to tell me. So I called her.
- Q. Were you upset with her for this?
- A. Yes.
- Q. What was this guy's name?
- A. Do I have to tell you?
- Q. Yes, why not?
- A. Stony.
- Q. Stony, Wait a minute. Then did she go to the dances after that?
- A. After what? No, she missed the next one, I mean she didn't go said she didn't feel like it. Then this was the next week.

- Q. Mike did you mind her going to the dance without you?
- A. Not at first; till I heard about her and Stony. We had an argument and I told her I didn't want her to go. After it was all over though I told her that if that was what she wanted to do she can do it.
- Q. Do you dance, Mike?
- A. No.
- Q. That's the reason you didn't go to the dances, is that right?
- A. Yes. I don't like to dance and I can't.
- Q. The girls seem to learn that and the boys don't. Now then, were you surprised when she called?
- A. Not so surprised. I just didn't think she'd do it. She's only called a couple of times. Once about Stony and then this time. It didn't really startle me, but
- Q. Did you wonder why she wanted to come and see you?
- A. I guess she just wanted to see me. I can't think of any other thing.
- Q. Mike, I notice you have a scratch on the side of your face there.
- A. I had a mole taken off.
- Q. You mean this one here?
- A. I had a mole taken off about six years ago.
- Q. Mike, you had some blood on your trousers?
- A. Yeah. That's when I got out of the car up at the horse. When I walked around the car and got caught on the front under the hood part as I was walking around you know.
- Q. In other words you say you caught the under part of your right hand on some hood decoration?
- A. Not on a decoration under the hood, as I was walking around; it's sort of sharp under there. I guess that's how it happened. I don't remember doing it.
- Q. May I see that again?

  Questioning by Chief Baldwin:
- Q. How far did you walk when you went over to look for her?

- A. Just Ingram and right back.
- Q. You walked out away from home and cut through the yards?
- A. Just Udry's.
- Q. Did you walk up to the stop sign?
- A. No.
- Q. How long did that take?
- A. Two or three minutes, I guess.

  Questioning by Don Roney:
- Q. Mike, are these the shoes you had on last night?
- A. Yes.
- Q. Did you get any blood on these from
- A. No.
- Q. What is this spot here?
- A. I was painting at my grandmother's.

- A. I had paint all over me. My mom just got a bottle of (?) and you see the spots left.
- Q. How close when you cut through the yards did you come to the area where Patty was found?
- A. About 20 feet. That's why I don't see how she could be there, because I don't think I could have missed her.
- Q. About what time was that?
- A. I got more trouble with time. About five till ten.

- Q. Now you say you returned home after walking up there?
- A. Yes.
- Q. How long before you went out again?
- A. I called her back about
- Q. You called her back?
- A. Yes.
- Q. And how long after that, what time did you leave home after that, and did you leave with anyone else?
- A. Well, I waited until about 1:00 or a couple of minutes after.
- Q. And did you leave with anyone else?
- A. Well, Mel come over, but first Mr. Rebholz come over and then he asked me if I saw her, and then Mel come over and he said "What are you going to do, sit up?" and I said "Yeah, I guess so" and he asked me "You can come with me if you want to" so I went in and told Mom, put my shoes on and a T shirt
- Q. And what time was that?
- A. About 11;30, no, about a quarter of 12:00.
- Q. Mike, when you were sitting on the porch did you see this Smith boy?
- A. No.
- Q. You didn't see him at all?
- A. No.
- Q. Before you walked through the cut-away you were sitting on the porch. He didn't pass by at all?
- A. Well, he might have. I didn't see him.
- Q. Later on when they came back where were you when they brought the hamburgers in?
- A. I was sitting there watching television.

- Q. You were where?
- A. In the front room of my house.
- Q. What was on television?
- A. "The Nurses".
- Q. "The Nurses" was on you say. Do you know what was on when they left?
- A. ----- I think, when my little sister went in to watch.
- Q. When you walked through the lot was there much light there?
- A. No, not too much I wasn't paying any attention. If she would have been there and I would have been looking for her I could have found her, but I didn't have the slightest idea, and didn't pay too much attention.
- Q. She had white clothing on to some extent.
- A. I know, that's what Jack told me.
- Q. You think it's odd that you wouldn't notice the clothing on the body.
- A. I don't know, I just cut through the field. I didn't have anything on my mind. I was walking toward the stop sign, just looking ahead I guess, and just stopped and whistled, and that's that.
- Q. The moon was out of course.
- A. Yes.
- Q, And you could see pretty well in the moonlight? Now when you walked over, the ----- has a dog. Did the dog bark?
- A. ----
- Q. Pardon?
- A. No.
- Q. The dog didn't bark?
- A. No.
- Q. Did you hear any music from any of the neighboring houses that was going on at that time?

- A. - I don't remember.
- Q. And were some people sitting out?
- A. Where were they sitting out?
- Q. Did you see anyone sitting out in a back yard or on a patio?
- A. I'm not real sure.
- Q. Do you recall whether you did or not?
- A. I was worried about her. I wasn't thinking of anything I guess.
- Q. And you don't recall whether or not you saw anyone sitting out? Did you notice any lights in houses there?
- A. It looked like the blue house had a light in it.
- Q. Which is the blue house?
- A. I don't know, right in back of Udry's.
- Q. Right in back of Udry's. Is that the corner house?
- A. Yes.
- Q. When you walked over did you look up and down the road?
- A. Yeah, I looked up Ingram.
- Q. You looked up ingram?
- A. Yes.
- Q. You looked up Ingram?
- A. Yes, then I whistled.
- Q. Which way did you go back then, Mike?
- A. The same way I came.
- Q. Then you heard no noise as you walked back and forward?
- A. Not that I can remember.
- Q. I mean noise that would have attracted your attention if you were looking for somebody?
- A. - -

- Q. Mike, on the clothing you have on, did you at any time spill anything on these clothing?
- A. Spill anything?
- Q. Yes.
- A. Not that I can remember.
- Q. Did you stain it in any manner?
- A. Just the blood, that's the only thing I can remember.
- Q. Yes, I mean are there any other stains other than the blood?
- A. Not that I can remember; I couldn't be sure.
- Q. You were pretty good friends, pretty tight, with Pat?
- A. Yes.
- Q. I mean you went out and dated? Quite a bit?
- A. Yes.
- Q. Was there anything real strong between you?
- A. No.
- Q. Other than high school and football, like that?
- A. Yes.
- Q. And you felt sort of engaged? She wore your ring?
- A. Yes.
- Q. What ring was she wearing?
- A. A gold ring with a black stone in it.
- Q. Is that a high school ring?
- A. No sir.
- Q. Was it a gift to you?
- A. From my grandmother.
- Q. When you saw the police car you didn't go over just right then?
- A. Not right away

- Q. At what time did you go near the scene later in the day?
- A. Yeah. Me and Steve and Cheryl were standing out there - - - so I walked around and then there was these newspaper guys. - - - Then this other gy came over with a camera. Then a lot of cars were stopping. Just a big -
- Q. When you saw this in the day time, how close would you estimate that you walked to that point the night before?
- A. I'd say around 20 or 25 feet. I just walked across the yard.
- Q. It seems to me that the light from that corner shines around Jennings - - ?
- A. MMMMMM Yes.
- Q. It is pretty light in there at the end of that lot where we found her?
- A. In the front or back of the yard?
- Q. In the back.
- A. I don't know; I can't tell you that; I guess it is.
- Q. Well, if she was there at the time you walked by you would have seen her wouldn't you?
- A. I thought I would have. I could have missed her if she had been there but I don't see I heard from people talking that she was supposed to have been killed there and I don't see how it could have been done unless it was after I walked there.
- Q. It must have been after. I don't see how you could have passed there,
- A. I don't either.
- Q. Without seeing the white clothing on the girl -- - -
- A. Was she?
- Q. \_ \_ \_ \_ \_ \_ \_ \_ \_
- A. I'm pretty sure that if she had been there I would have seen her. But I wouldn't bet on it cause I wasn't looking or anything. I mean I was just walking, I wasn't looking behind bushes or anything.

She wasn't behind a bush. She was right out here. I know, but - - -W. What time was it when you got back from walking there, Mike? I guess when I walked there it was about five till, so I guess it was about ten or a couple of minutes till. Did you go in the house when you got back? 0. Yes and I watched T. V. A. What show did you watch? 0. "The Nurses". The last part. A. Did you have any stockings on last night? No. I did at first, but I was in my swim trunks and then I got undressed. When she didn't come I got my pajamas on. When I got the 'phone call from Mrs. Rebholz I got my levis on, not these but the ones you have. When Mel came by and I went out and talked to him and he asked me if I wanted to go with him, so I just put my gym shoes on and a T shirt. Now you had been out there and back in the house before the kids got back with the hamburgers? Yes. A. Q. Coming back, they seen Craig Smith there? That's what they say, yes. A. That was what time? Q. Ten thirty I guess, I'm not sure. I'm so mixed up I don't know. A. They didn't see Craig going after the hamburgers? Q. A . No.

- Q. You know him very well?
- A. Who, Craig?
- Q. Yes.
- A. Yes, I know him, but not real well.
- Q. Do you get along with him all right? Any differences?
- A. Um last year he accused me of throwing tomatoes and ruining their patio. But it didn't bother me - - -
- Q. Did he know Pat?
- A. I don't think so.
- Q. Not at all?
- A. Well, I don't think so. He might, but he's in sports, but he's in track and she don't cheer for track.
- Q. Did she ever mention him?
- A. No.
- Q. Did he know she was your girl?
- A. I don't know if he did.
- Q. Have you talked with St. Clair this afternoon?
- A. Yes.
- Q. What time did you talk to him?
- A. Off and on all day; he has been down.
- Q. Did he tell you he was over here and talked to us?
- A. Yes.
- Q. Did he tell you what he told us?
- A. Oh, a few things, about going down with the car to the horse. He thinks you want to check something. I don't know, I'm not sure. And you're checking his shirt or something. He didn't tell us the whole thing. He just said he was scared to death.
- Q. Why was he scared?
- A. The same reason I am.

- Q. Why would you be scared, Mike?
- A. I don't know.
- Q. You haven't any reason to be.
- A. I am, though.
- Q. I mean we're not going to hurt anyone.
- A. I know.
- Q. You are just a young lad; you are just a boy, and there is nothing in the world can happen to you because you are just a boy. No matter what, if the very worst came to pass, nothing could happen to you because you're a boy.
- A. Ummmmmm.
- Q. You have no reason to fear for your life.
- A. I'm just shaky, I'm not really scared.
- Q. You know what I mean. No matter what if you did it still nothing could happen to you because you are only a boy.
- A. Yes.
- Q. There's no reason for you to be upset and shaky. We're just trying to find out how the girl came to an end.

- Q. At 6:30 this morning.
- A. Well, just that day.
- Q. I'm familiar with the Rambler automobile. The headlights are built up on the sides of the hood?

- Q. In other words, it's flat?
- A. Yes.
- Q. How did you manage to catch the inside of your wrist?
- A. I don't know; it could have been on that chrome part.

- Q. May I see your right arm? You have a few more abrasions here.
  ----- It looks like you might have jammed it. Do you know how that might have happened?
- A. No.
- Q. What about your left arm, please? Here, Mike, put your hands up here.

- Q. Do you know how she was dressed that night, Mike?
- A. - - I think you told me white blouse, pink slacks or short slacks )?)
- Q. How tall are you, Mike?
- A. About 5' 10½"
- Q. How much do you weigh?
- A. About 145 to 150.
- Q. Are you active in sports?
- A. Just football.
- Q. Did you play with Smith on the football team?
- A. He didn't go out for football; just cross-country and track.
- Q. Do you get along with him?
- A. I don; t know him that much. He's in a different grade than I am.
- Q. Is he a grade ahead of everyone else that age?
- A. He's a grade ahead of me and Pat.
- Q. The rest of you people are all 15 of so?
